- B. Proposed 2020-2021 Budget Presentation Overview**
Ordinance No. 2907 – First Reading
Appropriations (Budget)
Ordinance No. 2907 is before Council on first reading. This ordinance presents to Council the 2020-2021 proposed budget. The proposed budget contains anticipated and estimated revenues and expenses for the next fiscal year.
- C. Ordinance No. 2908 – First Reading**
Additional 1% for Budgeted Restricted Funds
Ordinance No. 2908 will allow the City of Alliance with a 75% affirmative vote by Council to exceed the Allowable Growth and Basic Allowable Growth for the 2020-21 Fiscal Year Budget by 1%. This does not increase the 2020-21 Fiscal Year Budget; it allows us to increase the unused budget authority for use in future years.
- D. Ordinance No. 2909 – Rezone Request within Starlite Addition**
Ordinance No. 2909 is before Council on first reading and will approve the Rezone Application from Fransie and Lidia Carillo requesting the rezone of Lot 3, Block 1, Starlite Addition to the City of Alliance, from RP-3 Planned Multifamily Residential to C-3, Heavy Commercial. The Alliance Planning Commission at their regular meeting on July 14, 2020 recommended denial of the rezone.
- E. Resolution No. 20-84 – Bid Award for Bulk Water Fill Station Rehabilitation Project**
Resolution No. 20-84 will award the Bulk Water Fill Station Rehabilitation Project to K.L. Wood and Company Inc. in the amount of \$38,039.
- F. Third Quarter Financial Statement Presentation and Acceptance**
Finance Director Waggener will present the Third Quarter Financial Statement to the Council for acceptance.
