Lot Sale to James and Kim Smith - Meadowood Addition

Ordinance No. 2754 will authorize the sale of Lot C, Block 4, Meadowood Addition to the City of Alliance, Box Butte County, NE. The purchase is being made by James V. Smith and Kim L. Smith in the amount of \$12,532.25 which is according to the pricing schedule previously adopted by the City Council. Copies of the Agreement for Sale of Real Estate and a location map have been made a part of the packet for Council's review. The Smith's have requested the waiving of three readings as there is a thirty day remonstrance period.

J. Ordinance No. 2747 – Third Reading Amendment to the Municipal Code - Height of Grass or Weeds

This ordinance is before Council on third reading and will amend the Alliance Municipal Code with regard to the height of weeds, grasses or worthless vegetation. Currently the Municipal Code restricts the height of weeds, grasses or worthless vegetation to twelve inches and this ordinance will reduce the height to eight inches. This change will allow our Code Enforcement Officer to initiate enforcement earlier in hopes of having problem areas remediated in a timely fashion. Additional language has been added to the ordinance to provide clarification, if it meets will Council's desire an amendment would be in order.

K. Ordinance No. 2752 - Third Reading

Two Mile Zoning Jurisdiction

Ordinance No. 2752 is before Council on third reading and will establish the City's two-mile area of planning and zoning jurisdiction outside our corporate boundary. The new two-mile area will include Carhenge which was previously excluded and a new area as a result of annexation.

L. Resolution No. 14-37 – Manager's Application for Ken and Dale's Liquor License

Resolution No. 14-37 will recommend the approval of Matthew Redecker as the Manager for Chuckwagon Fine Foods, Inc. dba Ken and Dale's Restaurant, 123 East 3rd Street, Alliance to the Nebraska Liquor Control Commission.
