C. Ordinance No. 2754 - Second Reading

Lot Sale to James and Kim Smith - Meadowood Addition

Ordinance No. 2754 will authorize the sale of Lot C, Block 4, Meadowood Addition to the City of Alliance, Box Butte County, NE. The purchase is being made by James V. Smith and Kim L. Smith in the amount of \$12,532.25 which is according to the pricing schedule previously adopted by the City Council. Copies of the Agreement for Sale of Real Estate and a location map have been made a part of the packet for Council's review.

D. Ordinance No. 2752 – Third Reading

Two Mile Zoning Jurisdiction

Ordinance No. 2752 is before Council on third reading and will establish the City's two-mile area of planning and zoning jurisdiction outside our corporate boundary. The new two-mile area will include Carhenge which was previously excluded and a new area as a result of annexation. The boundary is defined utilizing existing half-section lines.

E. Resolution No. 14-60 – Manager's Liquor Application for Terry's Corner

Resolution No. 14-60 will approve the Manager Application of Brent Fullmer for Western Cooperative Company dba Terry's Corner, 1639 West 3rd Street.

F. Resolution No. 14-55 – Authorization for the City Manager to Sign Contracts as Reflected by Nebraska Statutes

Resolution No. 14-55 authorizing the City Manager to have the ability to sign contracts which are \$30,000 or less when funds have already been budgeted, the agreement is for less than one year, and no additional personnel or obligation is necessary to execute the contract. The \$30,000 amount specified in the resolution coincides with the bidding level requirement within \$16-321 of the Nebraska Statutes.

G. Resolution No. 14-61 - Server Purchase

This resolution will authorize the purchase of the hardware and software for the computer server bank upgrade from Bytes Computer in the amount of \$39,604.82. This is year two of a three year upgrade process.

H. Resolution No. 14-62 - Electric Contingency Fund Authorization for PCB Disposal Expenses

Resolution No. 14-62 authorizes the use of \$50,200 from the Electric Contingency Fund for the disposal of PCB material by T&R Service Company.

I. Board Vacancies
