If approved, they are requesting Council recommend the issuance for a Special Designated Liquor License for the entire area.

H. Request for Permission to Fundraise for the Renovation of the Parks Sunken Gardens

Tami Swearingen a member of the Alliance Park and Tree Board is requesting permission to begin fundraising efforts for the restoration of the Central Park Sunken Gardens.

I. Ordinance No. 2832 - Third Reading

Municipal Code Amendment - Recreational Vehicle Parking

Ordinance No. 2832 is before Council on third reading. The ordinance will amend the Section 26-137 of the Alliance Municipal Code regarding the time limits for parking recreational vehicles. In January, 2016 Council approved an amendment to this Code limiting the parking from 7 days to 24 hours. This new amendment will increase the permitted parking time to 3 days.

J. Ordinance No. 2833 - Third Reading

Municipal Code Amendment - Trucks, Buses, and Medium or Heavy Duty Vehicles

When reviewing the previous ordinance, staff believed it would be best to also amend Section 26-133 which regulates the parking of trucks, buses and medium or heavy duty vehicles. As a result Ordinance No. 2833 is before Council for third reading and will adopt the U.S. Dept. of Transportation regulation which classifies vehicles into eight categories by weight and placing parking restrictions for those that are Class 6 and above.

K. Ordinance No. 2836 – Third Reading Amendment to the Classification Plan

This Ordinance will amend the City's Classification Plan by removing the Street Superintendent and the Water and Sewer positions and adding Water, Sewer and Streets Superintendent; and changing RSVP/Handyman Clerk to Community Services Clerk.

L. Public Hearing – Conditional Use Application of Karell Remodeling Services Resolution No. 17-49

Now is the date, time and place to conduct a Public Hearing on the application of Karell Remodeling Services & Properties, Inc. for a Conditional Use Permit to construct a building with multiple storage units to be leased to entities for the storage of personal property on Lot 1A, Replat of Lot 27, Block 9, Lakefield Addition to the City of Alliance, Box Butte County, Nebraska. The property is on the northeast corner of 25th Street and Emerson Avenue. The Alliance Planning Commission at their regular meeting on April 11th recommended approval of the Conditional Use Permit. Resolution No. 17-49 has been prepared for Council's consideration.

M. Resolution No. 17-50 - Mobile Children's Museum Site Location Selection

This resolution will authorize the closure of 9th Street between Sweetwater Avenue and the alley directly east (1/2 block) for the placement of the 150th Commission's Mobile Children's Museum. The Mobile Children's Museum will be in Alliance on May 23rd and 24th.

N. Resolution No. 17-51 - Compact Excavator Purchase for the Electric Department

Resolution No. 17-51 will authorize the purchase of a John Deere 17G Compact Excavator from Murphy Tractor and Equipment Company of Gering, NE through the National Joint Powers Alliance contract. This purchase is for the Electric Department and will be in the amount of \$25,503.10 which is within budget authority.

O. Resolution No. 17-52 - Ferno INX Power Cot Purchase

Staff is recommending the purchase of a power-assisted patient cot for our ambulance service. The purchase will be from Ferno, of Wilmington, OH in the amount of \$32,588.80 utilizing the FireRescue GPO cooperative procurement program.

P. 2nd Ouarter Financial Statement Presentation and Acceptance

Finance Director Waggener will present the Second Quarter Financial Statement to the Council for acceptance.

Q. Board Appointments and Resignations

The City currently has available one vacancy on each of the following: Board of Adjustment, A-2 Downtown Improvement Board and the Park and Tree Board. Anyone interested in serving on these Boards should contact the City Clerk's Office. Information on all of the City Boards is also available on our web site, www.cityofalliance.net.

R. Establish a Date for a Council Work Session

Staff is recommending Council establish a date and time to conduct a Work Session to review the Capital Improvements and Equipment Proposals. We believe a two hour time period would be adequate to complete the review and propose late in the afternoon of May 16th prior to our regular meeting. If that is not convenient we are open to Council's preference.
