F. Resolution No. 17-85 - Special Designated License Application

The City of Alliance has received a Special Designated License Application from the Hemingford American Legion Post 9 to serve alcohol for a wedding reception which is being held at the Masonic Temple, 123 West 3rd Street, Alliance. The event is on Saturday, October 28, 2017 between the hours of 5:00 p.m. and 1:00 a.m.

G. Resolution No. 17-86 - Use of City Council Contingency Funds

Staff is requesting the use of \$25,000 from the City Council's Contingency Fund. These funds are being used to clean up storm related damages which were incurred at the Alliance Cemetery and Central Park. Resolution No. 17-86 will authorize the requested transfer.

H. Resolution No. 17-87 - Airport Runway Rehabilitation State Grant Application

Resolution No. 17-87 has been prepared for Council's consideration and will authorize staff to apply for State funding for the rehabilitation of Runway 8/26. This project is anticipated to take place in the summer of 2018. The funds being applied for is a matching grant to cover up to 2% of the project costs.

I. Resolution No. 17-88 - NE Game & Parks Commission Berggren Plan Agreement and Addendum

Recently the City worked with the Nebraska Game and Parks Commission on a prescribed burn of 200 acres on Airport property. The controlled burn eliminated heavy thatch layers and will increase the plant diversity. As a result of this joint endeavor, the Nebraska Game and Parks Commission has requested to extend our hunting allowance for an additional five years in exchange for the cost of seeding. If approved our new agreement will expire in 2022 instead of 2020. Resolution No. 17-88 has been prepared for Council's consideration.
