The Alliance City Council met in a Regular Meeting, December 2, 2025 at 7:00 p.m. in the Alliance Learning Center Community Meeting Room, 1750 Sweetwater Avenue. A notice of meeting was published in the Alliance Times Herald on November 26, 2025. The notice stated the date, hour and place of the meeting, that the meeting was open to the public, and that an agenda of the meeting, kept continuously current, was available for public inspection at the office of the City Clerk in City Hall; provided the Council could modify the agenda at the meeting if it determined an emergency so required. A similar notice, together with a copy of the agenda, also had been provided to each of the City Council Members. An agenda, kept continuously current, was available for public inspection at the office of the City Clerk during regular business hours from the publication of the notice to the time of the meeting.

Mayor McGhehey opened the December 2, 2025 regular meeting of the Alliance, Nebraska City Council at 7:00 p.m. Present were Mayor McGhehey and Council Members Turman, Yates, and Hitchcock. Also present were Interim City Manager(s) Shoemaker and Brown, City Treasurer Baker, City Attorney Selzer and City Clerk Bedient

- First action taken by Mayor McGhehey was to excuse the absence of Vice Mayor Mashburn.
- Mayor McGhehey read the Open Meetings Act Announcement.
- The Consent Calendar was the first item on the agenda. A motion was made by Councilman Hitchcock, seconded by Councilman Turman to approve the Consent Calendar as follows:

Councilman Hitchcock inquired about Resolution No. 25-164, specifically asking how many BolaWrap devices the department currently has and whether there will be enough for each officer.

Chief Leavitt provided an overview and confirmed that the department will have sufficient BolaWrap units to ensure every officer is issued one.

- Council next held a public hearing for the Blighted & Substandard Study for the area bordered by Seventh Street to the North, Mississippi Avenue to the East, and Blighted and Substandard Area "5" to the East and South. The "Area O" area consists of approximately 31 acres area meeting minimum requirements to be designated as Blighted & Substandard.

**[RESOLUTION – BLIGHTED AND SUBSTANDARD STUDY FOR AREA “O”**

The Alliance Community Redevelopment Authority requested staff to perform multiple Blight and Substandard Studies for various parts of the City they thought might benefit from being declared Blighted and Substandard.

The Blight and Substandard Study for Area “O”, details how this area meets the requirements to be declared Blighted and Substandard, primarily due to the conditions of local infrastructure, conditions of structures, and the average structure age.

The Planning Commission held a Public Hearing at their November 11, 2025 meeting and concurred the Study showed the existence of Blighted and Substandard conditions. They voted to recommend the City Council accept the Study and include Area “O” as a Blighted and Substandard District within the City of Alliance after finding that said designation is consistent with the goal of housing rehabilitation in this neighborhood in the Comprehensive Plan. City Staff is also of the opinion that the Study and adoption of this area as Blighted and Substandard supports the goals and objectives of the City of Alliance Comprehensive Plan.

This area represents approximately 1.1% (34 acres) of the total acreage of the corporate limits (3137 acres) of the City of Alliance. If declared Blighted and Substandard, the total amount of area of the City declared Blighted will be 33.8% or 1060 acres. Cities of the First Class are permitted to declare up to 35% of their total area as Blighted and Substandard.

**RECOMMENDATION: APPROVE THE RESOLUTION ACCEPTING THE AREA “O” BLIGHTED AND SUBSTANDARD STUDY AND CREATING THE ASSOCIATED BLIGHTED AND SUBSTANDARD DISTRICT WITHIN THE CITY OF ALLIANCE.]**

Mayor McGhehey stated, “now is the date, time and place to conduct a public hearing to hear support, opposition, criticism, suggestions or observations of the taxpayers relating to the Blighted & Substandard Study for the area bordered Seventh Street to the North, Mississippi Avenue to the East, and Blighted and Substandard Area “5” to the East and South. The “Area O” area consists of approximately 31 acres area meeting minimum requirements to be designated as Blighted & Substandard. The Public Hearing opened at 7:07 p.m.”

Community Development Director Kusek came before the Council speaking in favor of the Blighted and Substandard Study of Area “O”.

No additional testimony was offered and the Public Hearing closed at 7:09 p.m.

December 2, 2025

A motion was made by Mayor McGhehey, seconded by Councilman Turman to approve Resolution 25-168 which accepts and approves the Blighted & Substandard Study for the area bordered by Seventh Street to the North, Mississippi Avenue to the East, and Blighted and Substandard Area "5" to the East and South.

#### RESOLUTION 25-168

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ALLIANCE, NEBRASKA:

#### RECITALS:

- a. Certain conditions exist in the "Redevelopment Area" (as defined below), as evidenced by the Blight & Substandard Study, Nebraska, Fairview, Miller Heights, 1<sup>st</sup> Addition Miller Heights, 2<sup>nd</sup> Addition Miller Heights Addition Areas "Area O", City of Alliance, Nebraska, dated August 5, 2025 (the "Study"), which is incorporated into this Resolution by this reference.
- b. The "Redevelopment Area" encompasses the following area in Alliance, Nebraska: The area bordered by Seventh Street to the North, Mississippi Avenue to the East, and Blighted and Substandard Area "5" to the East and South.
- c. At the Planning Commission meeting on November 11, 2025, a public hearing was held to determine whether the Redevelopment Area should be declared substandard and blighted and in need of redevelopment, as required by the Nebraska Community Development Law (the "Act"). At the public hearing, all interested parties were afforded a reasonable opportunity to express their views respecting the declaration of the Redevelopment Area as substandard and blighted and in need of redevelopment.
- d. The City Council considered the Study, the comments at the public hearing, and the recommendation of the Planning Commission in determining whether to declare the Redevelopment Area as substandard and blighted and in need of redevelopment according to the Act.

#### RESOLVED:

1. The Redevelopment Area meets the criteria set forth in Sections 18-2103(4) and (32) of the Act, as described and set forth in the Study, and the inclusion of all property in the Redevelopment Area is necessary to create a unified redevelopment area sufficient to encourage developers and redevelopment and to carry out the purposes of the Act.
2. The Redevelopment Area is declared to be substandard and blighted and in need of redevelopment according to the Act.
3. This resolution shall become effective immediately upon its adoption.

- The next item on the agenda for Council was Resolution No. 25-169 which will accept and approve the amendment to the City of Alliance Firefighters' Retirement Plan. The following information was provided:

**[RESOLUTION – FIREFIGHTER RETIREMENT PLAN SECOND AMENDMENT**

Earlier this year, the Nebraska Legislature passed LB 179, which made a small but mandatory update to the First Class Cities Firefighters Retirement Act. Because the City of Alliance participates in this Act, we are required to update the City of Alliance Firefighter Retirement Plan to remain in compliance with state law.

The amendment before you titled the Second Amendment to the City of Alliance Firefighter Plan makes one specific change:

- It adds a new optional distribution method for firefighters when they retire.
- Under the updated law, firefighters may now choose to receive “one or more partial payments in an amount or frequency elected by the participant.”

This update is administrative in nature and does not change anything about the structure or operation of the plan as a defined contribution plan.

- Contributions, employer obligations, vesting, investment structure, and benefit calculations all remain exactly the same.
- The only change is an additional option for how a participant may receive their already-earned account balance.

**RECOMMENDATION: APPROVE THE RESOLUTION APPROVING AMENDMENT 2 OF THE CITY OF ALLIANCE FIREFIGHTERS' RETIREMENT PLAN.]**

A motion was made by Councilman Turman, seconded by Councilman Hitchcock to approve Resolution No. 25-169. Which follows in its entirety:

RESOLUTION NO. 25-169

*WHEREAS*, The City of Alliance has a Retirement Plan for Firefighters; and

*WHEREAS*, The Nebraska legislature passed LB 686 which requires the Alliance Firefighters Plan to be amended to adopt certain changes:

*NOW, THEREFORE, BE IT RESOLVED*, That in order to adopt certain changes enacted under the Cities of the First Class Firefighters Retirement Act pursuant to 2025 Nebraska Legislative Bill 179, the City of Alliance Firefighters Retirement Plan (the "Plan") shall be, and it hereby is, amended in the form of the Second Amendment attached hereto and by this reference fully incorporated herein.

*NOW, THEREFORE, BE IT RESOLVED*, That the Mayor and other appropriate elected officials and officers of the City of Alliance shall be, and they hereby are, authorized to do all things necessary to carry out and accomplish the foregoing Resolution, including the execution of any document or amendment which may be necessary or appropriate to amend and administer the Plan, including such actions as may be necessary or appropriate to achieve and maintain qualification of the Plan under Section 401(a) of the Internal Revenue Code of 1986, as amended, as such sections apply to government plans.

- The next item on the agenda for Council was Resolution No. 25-170 which will approve entering into the contract with Cross Canyon Engineering in the amount of \$158,000 to perform substation drawing and updates for 10<sup>th</sup> Street Substation, 10<sup>th</sup> Street Substation engineering, equipment installation and commissioning, installation and commissioning of equipment at electric offices and related equipment. The following information was provided:

**[RESOLUTION: AWARD CROSS CANYON ENGINEERING CONTRACT**

Prior to energizing the solar field built by Sandhills Energy, a relay coordination study had to be performed between the 10<sup>th</sup> street substation, Broadwater substation and solar field. Cross Canyon Engineering, CCE, had worked with Sandhills Energy on several similar solar field installations. The City of Alliance hired CCE to complete the needed study and relay adjustments. As part of this work CCE identified several wiring issues in the 10<sup>th</sup> street substation. Over the years of operation of this substation, various wiring/relay changes were performed and not all of them were correctly recorded.

In the budget for '25 -'26 was substation upgrades. As part of the system upgrades that need to be implemented, a complete wiring diagram comparison and update needs to be performed. Also part of the system upgrade is establishing communication between all of the substations and the protective devices and our offices. This will be beneficial in outage notification and remote operation of breakers and system protective devices.

December 2, 2025

Cross Canyon Engineering has submitted a quote of \$158,000 to perform substation drawing updates for 10<sup>th</sup> street sub, 10<sup>th</sup> street sub engineering, equipment installation and commissioning, installation and commissioning of equipment at electric offices and related equipment installation.

Staff is recommending approval of contract with Cross Canyon Engineering.

Funds were budgeted in GL # 05-51-52-53-916, Electric Transmission, Substation.]

A motion was made by Councilman Yates, seconded by Councilman Turman to approve Resolution No. 25-170. Which follows in its entirety:

RESOLUTION NO. 25-170

*WHEREAS*, The City of Alliance owns and operates the Electric System; and

*WHEREAS*, Prior to energizing the Solar Field constructed by Sandhills Energy, a relay coordination study was required between 10<sup>th</sup> Street Substation, the Broadwater Substation and the Solar Field; and

*WHEREAS*, Cross Canyon Engineering (CCE) has previously worked with Sandhills Energy on similar solar installations and was hired by the City of Alliance to complete the required study and relay adjustments; and

*WHEREAS*, During completion of this work, CCE identified several wiring issues within the 10th Street Substation, resulting from various undocumented wiring and relay changes made over the years; and

*WHEREAS*, The FY 2025–2026 budget includes funding for needed substation upgrades, including a complete wiring diagram comparison and update as well as the establishment of communication links between all substations, protective devices, and the City’s electric offices to improve outage notification, remote operation of breakers, and system protection; and

*WHEREAS*, Cross Canyon Engineering has submitted a proposal in the amount of One Hundred Fifty-Eight Thousand Dollars and No/100ths (\$158,000) to perform substation drawing updates for the 10th Street Substation, engineering work, equipment installation and commissioning, and corresponding installation and commissioning of equipment at the electric offices; and

*WHEREAS*, Staff recommends approval of the contract with Cross Canyon Engineering to complete the required upgrades

*NOW, THEREFORE, BE IT RESOLVED*, by the Mayor and Council of the City of Alliance, Nebraska that the contract for substations upgrades be awarded to Cross Canyon Engineering in the amount of One Hundred Fifty-Eight Thousand Dollars and No/100ths (\$158,000) to be paid from GL # 05-51-52-53-916 Electric Transmission, Substation.

December 2, 2025

*BE IT FURTHER BE RESOLVED*, that the Mayor is hereby authorized to execute all necessary documents related to this contract and to take any actions necessary on behalf of the City of Alliance, Nebraska.

Electric Superintendent Bridge gave an overview of Cross Canyon Engineering.

### **Council Narrative – Purchase of Four Getac Laptops**

The Alliance Police Department is requesting authorization to purchase four Getac laptops and four vehicle docking stations to support the deployment of our three new patrol vehicles and replace one remaining non-Getac laptop currently in service. The total cost for this purchase is **\$17,847.52**.

This acquisition represents a key step in completing the department's transition to a fully Getac-based mobile computing system. The City's IT budget is already replacing three additional laptops this year, and the four laptops included in this request will finalize the department-wide conversion. With the upcoming implementation of new Getac body-worn cameras and in-car camera systems, transitioning all mobile data terminals to Getac ensures full compatibility, seamless integration, and improved reliability across all devices.

This purchase also aligns with the City's capital planning. The total cost of \$17,847.52 is **well under the \$50,000.00** allocated for computer replacement in **Capital GL 01-31-32-59-941**.

Approval of this request will allow the department to outfit the new patrol units, replace aging equipment, streamline technology platforms, and enhance operational efficiency and officer safety.

## **COMMUNITY AND CIVIC CENTER FINANCING FUND PROGRAM**

**Ordinance No. 3012**

**AN ORDINANCE OF THE CITY OF ALLIANCE, NEBRASKA AMENDING ALLIANCE MUNICIPAL CODE SECTION 26-127 TO RESTRICT PARKING ON THE NORTH SIDE OF WEST 10<sup>TH</sup> STREET WITHIN HILES ADDITION TO THE CITY OF ALLIANCE (COMMONLY KNOWN AS A-ROW) BETWEEN THE EAST LINE OF BUFFALO AVENUE TO THE WEST LINE OF CODY AVENUE; RENUMBERING EXISTING PROVISIONS; REPEALING EXISTING PROVISIONS OF THE CITY CODE NOT CONSISTENT WITH THIS ORDINANCE; AND PROVIDING FOR AN EFFECTIVE DATE.**

**BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ALLIANCE, NEBRASKA:**

SECTION 1. Section 26-127 of the Alliance Municipal Code is amended to read as follows:

**Sec. 26-127. Prohibited and limited parking.**

- (a) No vehicle may park at any time in the following spaces or locations, which spaces or locations may be painted red as appropriate but are not required to be:
- (1) In front of or within a space of 40 feet in front of the front entrance or entrances of any school;
  - (2) Where any other street or avenue intersects another, in the intersection of or within 25 feet from the intersection of the streets or avenues, beginning at the nearest perpendicular curb of the intersection;
  - (3) On the north side of First Street between the west line of Niobrara Avenue, if extended south, and the east line of Laramie Avenue if extended south;
  - (4) Within any alley or in a manner that obstructs the entrance or exit to the alley, and on a street or avenue within five feet of any alley entrance or exit, on either side, except when the actual operation of loading or unloading merchandise is in progress;
  - (5) In a manner that obstructs entrance or exit to any private drive, and on any street or avenue within five feet of any private drive entrance or exit, on either side, except when the actual operation of loading or unloading is in progress;
  - (6) On any street or avenue within ten feet of any fire hydrant, on either side of the fire hydrant, and within ten feet of any stop sign on the right side of any two-way street or on either side of any one-way street;
  - (7) Outside of the business district as herein defined, on that portion of any right-of-way outside the roadway, including in any curb strip as prohibited by chapter 20 of the City Code;
  - (8) On the south side of Sixth Street between the east line of Flack Avenue and the west line of Boyd Avenue;
  - (9) On the north side of Fourth Street between the east line of Flack Avenue and the west line of Boyd Avenue;
  - (10) On the north side of Fourth Street between the east line of Box Butte Avenue and a point 70 feet from said east line of Box Butte Avenue;
  - (11) On the east side of Boyd Avenue from Fourth Street to Sixth Street, except for those vehicles parked for residential purposes for immediately adjacent residential property;

- (12) On the east side of U.S. Highway 385 beginning at a point 301 feet south of the northwest corner of Section 4, Township 24 North, Range 48 West of the 6th Principal Meridian, Box Butte County, Nebraska, northerly along the highway right-of-way to a point where the highway intersects West Third Street in the city;
  - (13) On the north and south sides of Third Street from the west line of Howard Street Avenue westerly to the east line of Highway 385;
  - (14) On the south side of Sixteenth Street from the west line of Emerson Avenue to the east line of Buchfinck Avenue.
  - (15) On the north side of West 10<sup>th</sup> Street within Hiles Addition to the City of Alliance (commonly known as A-Row) between the east line of Buffalo Avenue to the west line of Cody Avenue.
  - (16) On any area and at any time where parking has become prohibited pursuant to article IV, chapter 26 of the City Code.
  - (17) In any manner not stated herein but that otherwise violates the State of Nebraska statutory rules of the road, as codified in R.R.S. 1943, ch. 60, as re-codified or amended from time to time.
  - (18) Any other parking space or spaces which may hereafter be designated by the city manager where parking shall be prohibited to provide for safety and the orderly flow of traffic and after such prohibited parking is plainly marked, painted on the curb or posted.
- (b) No vehicle may park Monday through Friday of any week between the hours of 8:00 a.m., and 6:00 p.m., and on Saturdays between the hours of 8:00 a.m. and 9:00 p.m., holidays excepted, as follows:
- (1) No vehicle shall park in the posted area in front of the U.S. Post Office building located on the northeast corner on Box Butte Avenue and Fourth Street;
  - (2) No vehicle shall park for more than two consecutive hours on the following described streets:
    - a. Box Butte Avenue from the north line of First Street to the south line of Sixth Street;
    - b. Laramie Avenue from the north line of Third Street to the north line of Fourth Street;
    - c. Third Street from the west line of Niobrara Avenue to the east line of Cheyenne Avenue;
    - d. Fourth Street from the west line of Niobrara Avenue to the east line of Laramie Avenue;
    - e. Fifth Street from the west line of Niobrara Avenue to the east line of Laramie Avenue;
    - f. Laramie Avenue north of Fourth Street for two parking spaces on the east side of the street and three parking spaces on the west side of the street.
    - g. For the west one-half block on the north side of Tenth Street between Niobrara and Sweetwater Avenues and the east side of Niobrara Avenue between 10th and 11th Streets, which time-limited spaces are plainly marked, painted on the curb or posted.
- (c) No vehicle shall park for a period of time longer than 15 minutes or 30 minutes, as either may be marked by signs, in a parking space in the municipal parking lot located southwest of the Library/Learning Center, Lot 1, Block 1, Library/Attendance Center Addition, which time-limited spaces are plainly marked, painted on the curb or posted.
- (d) Notwithstanding applicable portions of subsection (b)(2) above, no vehicle shall park for a period of time longer than 15 minutes in a parking space, or spaces, on Box Butte Avenue, which time-limited spaces are plainly marked, painted on the curb or posted.

- (f) Notwithstanding applicable portions of subsection (b)(2) above, no vehicle shall park between the hours of 6:00 a.m. to 6:00 p.m. on the east side of the 400 block of Niobrara Avenue from the north line of Fourth Street to a point 87 feet north of the north line of Fourth Street in the parking space or spaces which are plainly marked, painted on the curb, or posted.
- (g) No vehicle shall park for longer than one half hour on the East side of the street in front of the property at 903 Big Horn Avenue in the area designated by signage during the hours of 9:00 a.m. and 2:00 p.m. on Mondays and Tuesdays.
- (h) No vehicle, other than vehicles operated by the Alliance Police Department shall park on the east side of Niobrara Avenue in front of 511 Niobrara Avenue. The city shall, by signage, designate such parking areas as Police Parking Only.

SECTION 2. All ordinances, parts of ordinances, resolutions, and policies of the City of Alliance in conflict with this ordinance are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect from and after its approval, passage, and publication according to law.
